- How many teams? Last Year: 14 hoping for the same or more (in 2's)
- Length of Season April 17 July 13
- Ice Breaker Tourney May 13
- Year End Tourney July 15/16
- Secure deposit: \$100 non-refundable, 2 weeks before the AGM! (Feb. 17)

#### 4. Field costs and which fields do we have?

- Janet has requested: Cedar Hill Middle School Tue, Wed, Thu, + Braefoot Park
- If we have 16 teams will request Cedar Hill Rec
- If we have 18 teams will request Cedar Hill Rec for 2 nights
- We may need backup fields if/when we lose Cedar Hill Middle School. Hoping the School District will find/provide new fields for us as we are long term good customers.

#### 5. League finances and costs

- For 2022 we ended up with \$1,000 surplus due to various savings. Costs came in lower for toilets, balls, Exec meetings....
- For this year Karen has estimated costs for 14, 16 or 18 teams. This includes estimates for prizes at year-end tourney.
  - 14 teams = \$56 (deficit)
  - 16 teams = + \$81
  - 18 teams = + \$1528
- Last year we couldn't get toilets, which saved \$500. Fay will check to see if we can get them this year.

#### 6. What supplied to new teams if anything?

• Supply 6 balls to each new team to ensure they start off with the right ones! Buy 6 dozen to get the deal & use leftovers for the end of year tourney

• Will ask around to help advise new teams on bases & see if any other teams have spare equipment.
