

#### INDEMNITY AGREEMENT

Accidents arising from sporting and other recreation activities occasionally happen on Saanich property and facilities. Many activities include a foreseeable risk of harm and personal injury that are inherent in the activity itself. While the variety of risks are more than can be listed here, among the more obvious and frequent are trips and falls on playing fields, falls from equipment in gymnasiums, collisions with other players or users of Saanich property and facilities, and being struck with sports equipment such as balls and bats. In view of these risks, the following is a term of this contract:

YOU AGREE TO INDEMNIFY AND SAVE HARMLESS SAANICH AND ITS OFFICIALS, OFFICERS, EMPLOYEES AND AGENTS FROM ANY CLAIM, LAWSUIT, LIABILITY, DEBT, DEMAND, LOSS OR JUDGMENT (INCLUDING COSTS, DEFENCE EXPENSE AND INTEREST) WHATSOEVER AND HOWSOEVER ARISING EITHER DIRECTLY OR INDIRECTLY AS A RESULT OF THE GRANTING OF THIS CONTRACT OR THE USE OF SAANICH PROPERTY OR FACILITIES.

You also agree to waive all rights of subrogation or recourse against Saanich as a result of the granting of this contract or the use of Saanich property or facilities.

You will also indemnify and pay to Saanich promptly, on demand for any loss or damage to Saanich property and facilities arising either directly or indirectly as a result of the use of the property or facilities under the terms of this contract.

It must be produced upon request.

Should someone be in the location you have received this permit for, please kindly advise them of your permit and ask them to relocation to another area of the park.

The permittee shall report any damage or safety concerns to Saanich Parks immediately: 250-475-5522 or parks@saanich.ca.

- This permit and the privileges and obligations it contains are non-transferable.

- Saanich reserves the right to revoke this permit at any time.

- The permittee must collect and remove from the park all materials, equipment, garbage and waste, including compostable and recyclable materials, resulting from the permittee's activities (pack it in, pack it out or leave no trace protocols).

- The permittees is responsible for the controlling the conduct and actions of the permittee's participants and guests, and the permittee must remain on site for the duration of the permitted activities.

- Neither the permittee nor the permittee's participants or guests shall unreasonably disturb or interfere with the free use and enjoyment of the named park by other users.

- The permittee and the permittee's participants and guests are subject to all applicable laws, ordinances, regulations, requirements and recommendations of any and all Federal, Provincial, municipal and other authorities having jurisdiction, including but not limited to the District of Saanich's bylaws:

\* Parks Management and Control Bylaw, 1997, No. 7753

\* Noise Suppression Bylaw, 1993, No. 7059

\* Animals Bylaw, 2004, No. 8556

\* Tree Protection Bylaw, 2014, No. 9272

\* Fire Prevention Bylaw, 1997, No. 7755

While permittees are expected to abide by all bylaws without exception, the foregoing list sets out, for convenience of reference only, some of the bylaws that are most commonly applicable to permitted activities. This is provided for clarity and does not in any way relieve the permittee and the permittee's participants and guests from compliance with all applicable laws.

- Parking of motor vehicles is permitted only in designated areas, and overnight parking (between the hours of 11 p.m. and 6 a.m.) is prohibited unless express written permission is granted by Saanich. For certainty, and without limiting the generality of the foregoing, parking is prohibited on turfed areas and adjacent to trees.

- Posting of any signs in the park is prohibited unless express written permission is granted by the Parks Manager.

- Any sale, service or consumption of alcohol in the park is prohibited unless express written permission is granted by Saanich, and unless the permittee holds a valid liquor licence for that purpose.

- Smoking, including vaping and cannabis use, is prohibited everywhere in the park, pursuant to Capital Regional District Clean Air Bylaw No. 3962.

- Construction or placement of tents or other temporary structures in the park is prohibited unless express written permission is granted by Saanich.

- Nothing may be affixed to any tree, building or other park property or facility unless express written permission is granted by Saanich.

- All park visitors will respect the free use and enjoyment of the park by other visitors and the peace of adjacent private property owners (neighbours).

- The permittee is responsible for any damage or injury caused to persons or property, including private property, as a result of the use of the park for the permitted activities by the permittee and the permittee's participants and guests.

- No selling of any goods or services (including food sales) permitted without specific written approval.

Condition of Use - Park Sports Event Apr 15, 2024

Use of municipal buildings and recreation areas/facilities are subject to the following conditions. Infractions of these rules could result in permit being revoked.

- Permitted activities must remain within designated areas. No permittees or park visitors shall interfere, become a nuisance or hazard to other persons using the park.

- Use of amplification devices require permission from the Park Manager and shall not disturb other park visitors or park neighbours. Amplification may only be used to announce games and not to play music or broadcast professional sports.

- Use of lights: Use of sports facility lights must be approved by the Park Manager and must be off by 10 p.m. nightly.

- Advertising: absolutely no form of advertising is allowed without explicit written permission from the Park Manager.

- Putting up tents or temporary shelters in any park require explicit permission from the Park Manager.

- Litter and grounds care: the permittee is responsible for collecting and removing litter and recycling created by their participants.

- Permittees are responsible for damage created to the park or its facilities and any damage to adjacent properties that results from the permittees or their participants' activities.

- Permittees must leave facilities and surrounding areas clean and safe after each use.

- Any food services provided must adhere to all local health regulations.

- Sports fields to be inspected prior to each use. Remove any debris and if needed fill holes. Report any concerns to parks@saanich.ca. Fields must not be used if overly wet or frost/snow covered. Saanich Parks may close fields and no play allowed during field closures. http://bit.ly /FieldStatusSaanich

SOCCER USE: Group responsible for all nets. Goal posts are not Saanich Parks assets but on site from home user group user agreements. Posts must be secured while in use. After each use, goals to be moved off the field and left secured.

BALL USE: Group responsible for own bases. Dugout and club house access only via home user group. Any field raking or mowing must be performed according to standards set by Saanich Parks.

LACROSSE BOX: Group responsible for inspecting box and removing any debris prior to use.
